**APPROVAL OF AGENDA**

**MOTION** by Council Member Sobon seconded by Council Member Behiel and carried 5-0 APPROVING THE AGENDA AS PRESENTED.

City Administrator, Michael McHatten stated that the City Engineer is working with the church on the issues.

**1. ELECTION OF MAYOR**

**MOTION** by Council Member Behiel and seconded by Vice Mayor Morris to appoint Council Member Sobon as Mayor. Mr. Sobon said he was honored but to keep a continuity within the City, he withdrew himself from consideration stating that the current Mayor represents the City well. After discussion, The motion was withdrawn.

**MOTION** by Council Member Sobon to retain Mayor Kulm for another year as Mayor. Seconded by Vice Mayor Morris and carried 5-0.

**2. ELECTION OF VICE MAYOR**

**MOTION** by Vice Mayor Morris to appoint Council Member Folendorf as Vice Mayor for one year. Seconded by Mayor Kulm and carried 5-0.

3. **MUSEUM COMMISSION CANDIDATE INTERVIEWS**

Mayor Kulm stated that since there were two vacant seats and only two applicants for the seats, interviews were unnecessary unless the Council wished to interview each applicant. The Council agreed with Mayor Kulm. The Mayor asked each applicant to come forward and introduce themselves and explain why they wanted to be on the Commission. It was discovered at this time that applicant Clarence Rogers was not in attendance. Applicant Joseph Oliveira introduced himself and explained he was a docent with the museum and thought the Museum was a gem in the City.

**MOTION** by Council Member Sobon, seconded by Vice Mayor Folendorf and carried 5-0  
**APPOINTING JOSEPH OLIVEIRA AS MUSEUM COMMISSIONER TO FILL THE REMAINING TERM ENDING JUNE 30, 2018.**
