**5:30 p.m. CALL TO ORDER**

Chair Morris called the City Council meeting to order at 5:30 p.m. The City Council convened to closed session. Chair Morris reconvened to open session.

**6:00 p.m. REGULAR MEETING**

**PRESENTATION**

Kimberly Arth, Museum Director, reported the Angels Camp Museum has been voted best museum by the Sierra Lodestar. Three counties were included for grand prize – Calaveras, Amador and Tuolumne.

**APPROVAL OF AGENDA**

MOTION by Council Member Sobon, seconded by Council Member Kulm and carried 5-0 APPROVING THE AGENDA AS PRESENTED.

**STAFF UPDATES**

The following questions/comments were raised from information received in the staff consolidated report:

Council Member Kulm asked when the “State of the City” report was to be presented to Council. The City Administrator said he expected to present it in March.

Council Member Kulm commended the Museum Director and the Commission for giving a guided tour of the Museum to WorldMark staff. He said this should be offered to other agencies/businesses in the City to make them aware of the Museum and so make their customers aware.

Council Member Lynch asked if the City’s request that SR4 be designated as a business route be moved along more quickly if Caltrans District 10 or Assemblyman Bigelow were contacted. The City Administrator reported that Caltrans has granted approval and has assigned a Traffic Engineer to work on this. It is in the right hands.

Council Member Lynch the status of the Landscape/Tree ordinance. The Planning Commissioner said it would be reviewed by the Planning Commission at their March meeting and come to Council for approval in April.

Council Member asked if the City has what plans the City had in moving forward in correcting the sprayfield pipe failure. The City Engineer reported that staff is looking at the problem and working on implementing a

solution. He is working with the consultant on what exactly is needed to correct the problem. Mr. Lynch asked that Council be advised of the status with an update provided to monthly.

- Attended CCOG sponsored Bike/Pedestrian workshop at Bret Harte. The workshop was not well attended by the public from Angels Camp. The same workshop held in San Andreas was well represented.

### **Consent Item 'b' – Approval of Partnership Planning Grant Sub-Recipient Agreement between the City of Angels and Calaveras Council of Governments**

Council Member Kulm said he was pleased with the award of the Planning Grant but had concerns of what responsibility Caltrans has in the grant project process. The Planning Director explained that although the agreement is between the CCOG and the City, Caltrans will be instrumental throughout the project process.

## **REGULAR AGENDA**

### **1. PUBLIC HEARING CONTINUED FROM JANUARY 7, 2014: ADOPT ORDINANCE NO. 464 APPROVING THE REZONE OF 86 PARCEL AND AMENDING THE ZONING MAP**

This item was continued from the January 7<sup>th</sup> meeting. Council had asked staff to research the General Plan process to see if there were any documented reasons for the inclusion of 3 R-1 parcels to be zoned as Historic. The Planning Director said he looked at past notes and other documents left from the General Plan committee and he found no known reason why this was done. Council Member Raggio said he was steadfast in his belief that these parcels were zoned incorrectly in the General Plan and he would not be supporting the proposed Ordinance.

Mayor Morris asked if there were any members of the public who wished to speak on this item. There being none, the Public Hearing was closed.

The City Attorney explained he could draft a text amendment to the Historic Commercial Zoning District to allow pre-existing residential parcels to be conforming uses under that district. The Council agreed this would resolve the issue.

MOTION by Council Member Kulm, seconded by Council Member Sobon and carried 5-0 ADOPTING ORDINANCE NO. 464. AN ORDINANCE AMENDING SECTION 17-12-020 OF THE CITY OF ANGELS MUNICIPAL CODE. **NOTE: A SEPARATE TEXT AMENDMENT IS TO BE SUBSEQUENTLY ADOPTED TO REFLECT THAT PRE-EXISTING RESIDENTIAL USES (FORMERLY IN THE R-1 ZONE) FOR PARCEL LOTS 5, 9 AND 10 WILL CONSTITUTE CONFIRMING USES IN THE HC ZONE.**
