NOTICE OF PUBLIC HEARING

**RENEWAL OF WASTE DISCHARGE REQUIREMENTS
(NPDES NO. CA0085201)**

For

**CITY OF ANGELS
WASTEWATER TREATMENT PLANT
CALAVERAS COUNTY**

The City of Angels is the owner and operator of the City of Angels Wastewater Treatment Plant (Facility), a publicly owned treatment works located at 3000 Centennial Road, Angels Camp, California. The Facility provides sewerage services for the City of Angels and Six Mile Village, serving a population of approximately 4,185 people. The Facility provides tertiary treatment for up to 1.9 million gallons per day (MGD). Tertiary treated wastewater from the Facility is discharged to Angels Creek, a water of the United States.

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2012-0088, issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 4 October 2012. An Order is proposed to renew the NPDES permit. The proposed permit includes new effluent limitations for cyanide and zinc. The permit removes effluent limitations for electrical conductivity because the discharge does not demonstrate reasonable potential to cause or contribute to instream exceedances of the applicable water quality objectives for this constituent.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 10 April 2017**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board via email to **RB5S-NPDES-Comments@waterboards.ca.gov** no later than **5:00 p.m. on 10 April 2017**. Written

evidence or comments submitted after **5:00 p.m.** on **10 April 2017** will not be accepted and will not be incorporated into the administrative record absent a ruling by the Board Chair. Any party requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that accepting the late submission will not prejudice the Central Valley Water Board or any Designated Party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
