1. ROLL CALL

All Council Members were present.

2. APPROVAL OF THE AGENDA

ACTION: MOTION BY COUNCIL MEMBER OLIVEIRA, SECOND BY VICE MAYOR HERMANN, AND PASSED 5-0, TO APPROVE THE AGENDA.

3. PUBLIC COMMENT

4. CONSENT AGENDA

Council Member Oliveira asked to pull Items A, B and C for discussion.

ACTION: MOTION BY COUNCIL MEMBER METILDI, SECOND BY COUNCIL MEMBER BEHIEL, AND PASSED 5-0, TO APPROVE ITEM D OF THE CONSENT AGENDA.

- D. Approval of Purchases and Budget Adjustments
- A. Approval of Minutes of Regular Meeting of November 20, 2018.

Council Member Oliveira was concerned that no item had come forward to address Gary Gordon's concerns about alternate emergency access to the annex area which was brought to Council on November 20, 2018 during the Public Comment portion of the City Council Meeting.

ACTION: MOTION BY COUNCIL MEMBER BEHIEL, SECOND BY COUNCIL MEMBER OLIVEIRA, AND PASSED 5-0, TO APPROVE ITEM A OF THE CONSENT AGENDA.

B. Appointment of Mary Kelly as City Treasurer/City Clerk

Council Member Oliveira asked that the Offices of City Treasurer and City Clerk be put on the ballot for the June election with a better process for educating the public of the need to make the positions appointed.

C. Adoption of a Salary Schedule for Part Time Employees of the Fire Department

Council Member Oliveira asked staff how many part time Firefighters were brought into PERS membership due to the new salary schedule. Susan Wenger, Director of Administrative Services and Nathan Pry, Fire Marshall, told Council that the majority of Firefighters had already been brought into membership either by tripping the hours limitations in prior years or by their membership in another agency.

B. Approval of the Transfer of \$60,000 from Water Fund to Wastewater Fund to Address Capacity Issues in the Wastewater Distribution System and Authorize Consultant to Submit a Construction Application for State Funding of Associated Improvements - Amy Augustine, AICP Contract Planner
