**RECOMMENDATION**

Make recommendations based on the workshop and discussion items for the City of Angels Strategic Plan.

**BACKGROUND**

The City of Angels has contracted with Citygate to be involved in Phase II of the City of Angels Strategic Plan.

**DISCUSSION**

Citygate provided a survey to City employees and members of the public. 21 Employees and 234 members of the public responded. Both response totals are impressive. The information regarding the responses has been tabulated and analyzed to identify the top rated in various categories and which rated highest, meaning doing well or meaning not doing well.

There are many surprises in the results. However, it does confirm what many of us already know or have been seeing. While many projects and changes have occurred over the past nine months, those results still need to be felt or have a multi-year implementation; the City will need to continue to work on public outreach and updates.

The Strategic Plan is a roadmap for future decisions. These decisions drive budget, local policy, and public and employee interactions by staff and Council. The Strategic Plan is also a living document that should be regularly reviewed and evaluated to ensure accountability across the organization.
