- The City Administrator had no additional items to add to the consolidated report included in the packet. Council Member Sobon asked the City Engineer if the water sampling kits supplied to homeowners were distributed to different location segments throughout the City. He was told that they were.
- Council Member Lynch asked the status of the CDBG grant applied for. The City Administrator stated \$100K was awarded for tourism.

- Council Member Lynch asked the City Engineer what level of led was being used for homes being tested. The Engineer said the level of led being used is .15 parts per billion. Mr. Lynch stated it must be per million and asked the Engineer to supply additional information.
- Council Member Raggio asked the status of the sidewalk project. The Planning Director explained they are awaiting a storm water/pollution control plan before work can start.
- Council Member Lynch reported that Tribal Resource Specialist for the MiWuk Tribe, Debbie Grimes, will be making a presentation at the museum on November 14th. He also reported the museum is now open year-round. Thursday through Monday from 10:00 am 4:00 pm.

3. ANALYSIS OF CITY GUIDELINES ADOPTING OPEN & ORDERLY PUBLIC MEETINGS

Derek Cole, City Attorney, provided an analysis of the City's guidelines of open and orderly public meetings that is posted on the City's website. He reported that overall the guidelines are accurate. He pointed out that guideline #3 allows 3 minutes for public comment and some agencies allow up to 5 minutes. Council Member Lynch felt 5 minutes was a reasonable time allotment for the public.

Council Member Sobon and Council Member Raggio agreed that the 3 minute time allotment was fine and Mr. Sobon pointed out that Council has the option to extend the time.

Mr. Cole said that he did have some issues with the wording of guideline #5. The guideline, in part, says "a person addressing the Council shall not make repetitious, slanderous or irrelevant remarks". Mr. Cole explained that the Council may not want to hear certain remarks but they cannot stop someone from saying things in their own words. Council Member Lynch stated that Council must listen to criticism and recognize the fact that the public has the right to criticize.

Mr. Cole said he also reviewed the City Council handbook and found it to be generally good but requires some updating.

It was agreed that the City Attorney will reword Guideline #5 and also make some minor revisions to the Council Handbook. He will bring both documents back at the same time for council review.
